



Guidelines for the 2020 ACS BIOT Marvin J. Johnson Award in Microbial and Biochemical Technology

Sponsored by Pfizer, Inc. Deadline: August 1st, 2019

Purpose:

To recognize outstanding research contributions toward the advancement of microbial and biochemical technology.

Nature:

The Award consists of \$5,000 to cover honorarium and travel expenses, to attend an annual meeting of the Biological Technology Division of the American Chemical Society, and a plaque. It is presented by the Division of Biochemical Technology at the Spring meeting of the American Chemical Society. An address by the recipient on his/her research at the annual meeting is part of the Award Ceremony. The Award was established in 1978 and is supported by Pfizer Inc.

Eligibility:

The nominee shall have accomplished independent and original research that has exceptionally significant impact upon the field of microbial and biochemical technology. He/she shall be a divisional or national member or affiliate of the American Chemical Society.

It is expected that the award recipient will register and attend the conference and present an award lecture.

The sponsor must also submit:

- a) A letter of support from sponsor with a complete description of the nominee's research contributions for which the Award is intended (3 pages or less)
- b) Curriculum vitae (25 pages or less)
- c) Letters of support from two additional persons. Letter writers should write for (or sponsor) only one Johnson Award nominee in a given year. (2 pages or less per letter)

Procedure for Nomination:

All BIOT division members are encouraged to submit nominations. The deadline for nominations is August 1st. The form provided below should be completed and sent by email (only) to the address listed on the form.

Selection:

The awardee is selected from among the nominees by a committee of prior recipients and senior BIOT members convened by the BIOT Division Awards Chair.
